Final Comments & Questions

Apart from the points mentioned above, I commend the systematic approach to the subject matter, thorough and carefully planned research design, and a clear connection with classroom practice.

My criticism would be directed towards the scope of the literature reviewed and referred to in the theoretical section. Apart from relevant mentions of the historical background of the field, I suggest the author also should look beyond the confines of the local context and turn to global experts, which would lend her theoretical part more academic persuasiveness.

I propose the following points for discussion at the thesis defence:

1/ Could the author compare her own experience with the implementation of the interdisciplinary approach and project work as a student (pre-university) and as a teacher?

2/ In what manner has the writing of the thesis enriched the author in terms of her overall knowledge of the topic and/or ideas for a potential change?

Based on the reasons stated above, I recommend this thesis for defence and propose the assessment of 1, výborně.
