## Final Comments & Questions

The above assessed undergraduate thesis focuses on the category of gender of the English noun. The work starts with an excellent introduction into the issue, which furthermore presents a comprehensive lay-out of the thesis.

The theoretical part firstly provides the description of this category from the historical point of view, which creates a relevant starting point for the following analysis. Here, in this part of the theoretical description, I miss the description of the status of the nominal gender in the earlier stages of English. The author should have paid more attention to the gender of the English noun from the historical point of view. Nevertheless, the description of gender from the sociolinguistic point of view is in my opinion one of the most successful parts of the work. The author took into consideration various sociolinguistic points of view of the category of nominal gender, and was able to provide a valuable overview of it.

The Practical part provides a profound description of the individual steps preceding the actual analysis of the excerpts (the actual analysis of the excerpts is then in the appendix) as well as a sound discussion of the results obtained from the analysis. The author is considering individual nouns and their gender from the grammatical and the sociolinguistic points of view and is able to capture and describe the principles of shifting of understanding the gender.

In the initial paragraphs of the chapter Conclusions, the author summarizes the preceding steps, which in my opinion is irrelevant. On the other side, in the main part of the chapter she comes to

relevant conclusions, which, again, could have been elaborated and presented in more detail, owing to the perfect discussion in the previous chapter.

As far at the general requirements of the thesis are concerned, the author definitely proved her ability to work in concord with the principles of academic writing; the language of the work is at a very high level, and the references are cited properly.
